Three (3) ways to pay: (All rates except for Monthly Draft must be paid-in-full in advance)
 ~ **Cash or Check**
 ~ **Monthly Draft** from *savings* or *checking* account or *credit card*
 ~ **Credit Card** (credit card payment accepted at YMCA Fitness Center, 2021 Main Street)

Day & Month Member entitles the user to full YMCA Membership privileges for that day or month. **Exception:** Day / Month Youth Membership does not entitle enrollment in Youth Programs at Member rate.

Family / Household: Family / Household members must reside at the same address and pay monthly dues from one account. The individual (Adult or Senior) completing the application is responsible for payment. Verification of residency will be required of adult members. Youth must be eligible to be enrolled in Baker County or North Powder school districts and reside at the same address as the paying adult.

College Member: must be a current full-time student (at least 36 credits) at an accredited college. Proof of enrollment / credits may be required. Fee must be paid in full.

*** The Joining Fee** (which is in addition to the first month fee) is waived for:

- ~ full Annual pre-payment; and
- ~ Monthly Draft in force for 12 continuous months

NOTE:

- ☞ Monthly Drafts cancelled **prior** to 12 months will be charged \$80 for the first individual to cancel and \$30 for each additional individual, up to a maximum of \$140☞
- ☞ A 30-day notice must be given prior to cancellation of memberships.☞
- ☞ Any additions to membership in Month Draft membership will “restart” the 12 continuous month agreement.

Verification of Residency for YMCA "Family / Household" Adult Membership:

Verification / proof of residency **must include** the **person's name and address** as listed on the YMCA Membership form and may include the following forms:

- ✓ Current Driver's License
- ✓ State Issued Identification Card
- ✓ Passport

- ✓ Proof of Insurance (car, home, life, medical, etc.)
- ✓ State or Federal Income Tax statement from the current tax year
- ✓ Current Motor Vehicle Registration or Title

- ✓ *Current Magazine Subscription
- ✓ *Oregon Trail Electric Company bill
- ✓ *City Utility Bill
- ✓ *Copy of Unemployment Check
- ✓ *Copy of most recent pay check stub
- ✓ *Current Bank Statement
- ✓ *Credit Card Statement
- ✓ *Oregon Trail Gas Company bill
- ✓ *Baker Sanitary Service bill
- ✓ Other ID approved by YMCA Management Staff

* These items must be dated within the previous 45 days.

Residential address is the location at which a person is physically present and regards as home; a person's true, fixed, principal place of dwelling.
